**This Guaranty shall not be limited on amount. Guarantor understands that service is being extended to customer in partial consideration of the execution and delivery of this Guaranty. Guarantor acknowledges receipt of good and valuable consideration of this agreement.**

**Guarantor agrees to pay all amounts due upon demand and further consents to NU transferring any unpaid amounts hereby guaranteed to any account guarantor maintains with NU, the same to be treated like any outstanding utility debt owing. Any forbearance on the part of NU of any remedy shall not be construed as a waiver of that remedy. In the event of default in payment of debts/amounts due, NU may bring suit on said debt guaranteed against customer and Guarantor or against Guarantor alone.**

**In the event that NU files suit to enforce any provision of this agreement, Guarantor agrees that the Court shall assess reasonable attorney's fees and costs of litigation against Guarantor. The Guarantor may withdraw/terminate this guaranty by giving NU notice in writing delivered at least sixty days (60) in advance of effective date of termination. Such termination shall not relieve Guarantor of liability for obligations incurred prior to effective date of such termination.**

**I understand that I am giving my permission to Newport Utilities to do a credit check of my personal credit history. I also understand that, pending the results of said credit check, that I may be notified to make other arrangements for this contract.**
