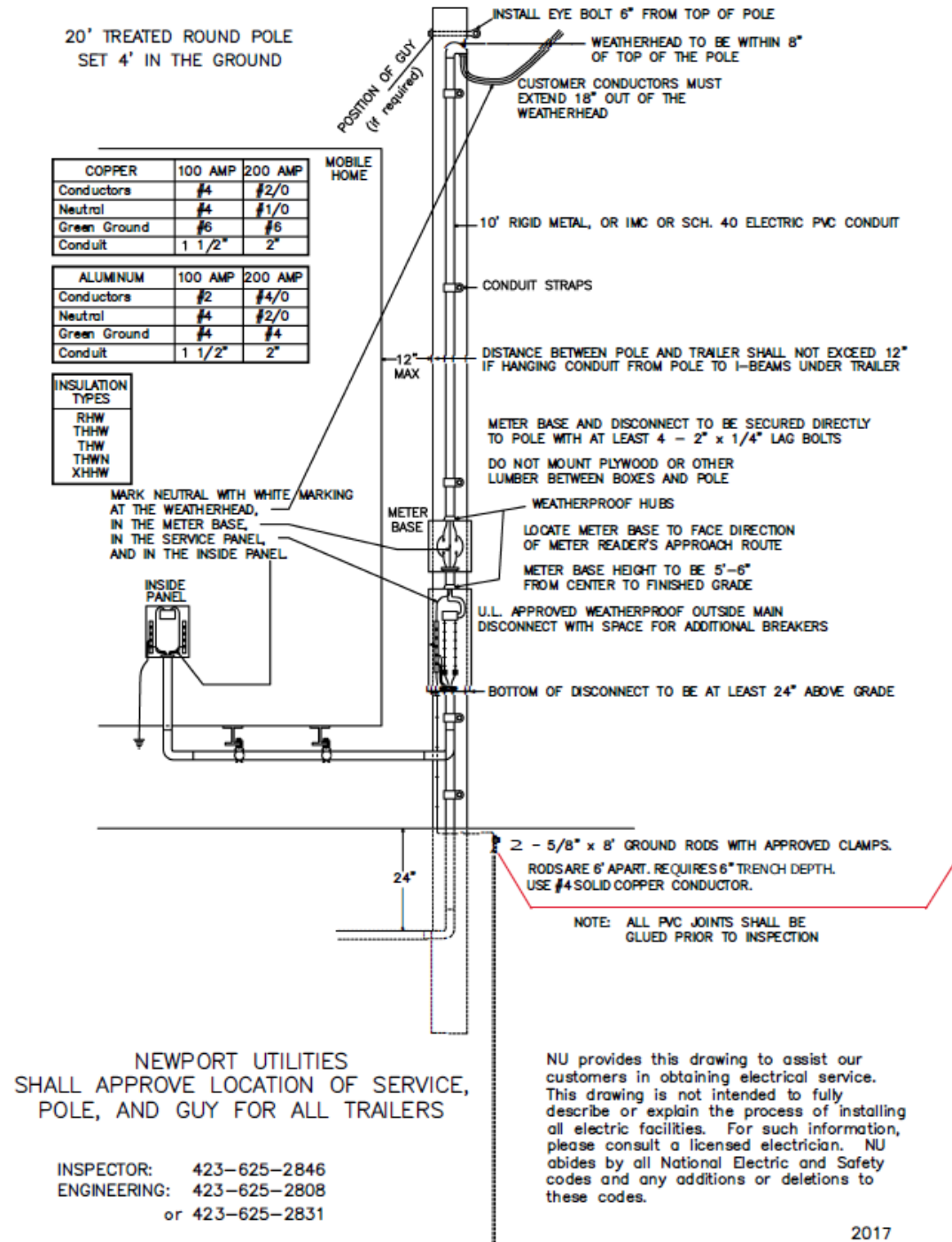

State of TN Electrical Regulations

Occupancy of a dwelling is prohibited before final inspection has been completed and approved. Inspection permits have an expiration date of two (2) years from the date of issuance.

All mobile homes require an anchor decal to be purchased by a licensed anchor installer. The decal must be affixed inside the electrical panel box cover. The electrical inspector cannot authorize electricity to be turned on at the home if no anchor decal is on the home.

Licensed electricians are required to purchase inspection permits for any electrical work they have done for a customer. The homeowner may perform electrical work (for which an inspection is required) upon his own residence providing he obtains a property owner's electrical permit.

Failed Inspection

If an inspection fails approval, a new electrical permit must be applied for and obtained. Reinspection must be done within 30 days from date of rejection.

Service Only permits/inspections: The inspector allows temporary service for 45 days. No occupancy in dwelling is allowed. If home or service is not ready for final inspection within 45 days, the purchase of a Service Only extension permit is required and the electrical inspector will have to reinspect to grant the extension.

Newport Utilities may be required to disconnect power if final inspections are not granted within the required timeframe as defined by State of Tennessee Code.

Failed Inspection (continued)

Important Information

- NU engineers must spot the location for your meter base after fees are paid.
- You are responsible for setting your service pole for a mobile home, temporary service pole, or underground pedestal.
- The State Inspector is available Monday and Wednesday only. Please schedule an inspection at least 72 hours in advance online at www.core.tn.gov.
- In some cases, you may be required to trim and/or cut trees before the poles and lines are set. NU engineers will advise you.

Water Treatment and Tap Fee

Newport Utilities' water supply meets or exceeds established water quality standards prescribed by the Safe Drinking Water Act of the Environmental Protection Agency. Fluoride is added to comply with water quality.
